### SIA carries out multiple, simultaneous raids in Kashmir

**Srinagar, Dec 26 :** The State Investigation Agency (SIA) on Friday started multiple, simultaneous raids at several locations in the Kashmir Valley in connection with terror-related activities. Official sources said that the SIA sleuths, assisted by the Central Reserve Police Force (CRPF), conducted simultaneous raids at 11 locations in Srinagar, Ganderbal, Handwara, Sopore and Baramulla. "These raids are part of the investigating agency's continuing effort against terrorists, their over-ground workers (OGWs) and sympathisers," the sources said. So far, no arrests have been made, and a detailed statement will be issued after the conclusion of the raids, the sources added. On May 11, the SIA raided 20 locations, including those in Anantnag, Pulwama, Kulgam and Shopian. These



raids are part of the high-stakes investigation into a terror conspiracy case in which sleeper cells of the terrorist outfits were found to be in contact with their handlers across the border. "The accused against whom raids are in progress today are known to have shared sensitive information about security forces and critical infrastructure using encrypted platforms like Telegram, WhatsApp and Signal," the sources said.



### Tripura govt pitches state as emerging tourism hub : CM Saha

**Agartala, Dec 26 :** The Tripura government, with support from the ministries of Development of North Eastern Region (DoNER) and Tourism, is working to develop the state into a major tourism hub to attract domestic and international visitors, generate employment, and boost revenue, Chief Minister Manik Saha said on Friday. Referring to his virtual meeting held on Thursday with DoNER Minister Jyotiraditya Scindia, the Chief Minister said that Rs 451 crore has been approved for the implementation of 21 tourism-related projects in Tripura. ### Refusal to fetch cigarette for stranger costs software engineer his life in Bengaluru; accused arrested

**Bengaluru, Dec 26 :** A shocking incident came to light in Bengaluru on Friday, where a software professional was killed following a petty quarrel over fetching a cigarette for another man. The stranger, who asked the soft-

ware professional to fetch a cigarette for him, allegedly rammed his car into the man's motorcycle from behind and has now been arrested by the police. The deceased has been identified as 29-year-old H.N. Sanjay, a resident of Vajarahalli in Bengaluru.

The incident occurred at Vasanthapura Cross on Kanakapura Road. The accused, 31-year-old Prateek, a resident of Rajarajeshwari Nagar, works as a manager at a private company. The police have obtained CCTV footage of the horrific incident and

have registered a case of murder. According to police, on May 10, Sanjay was smoking a cigarette on the roadside along with his friend, Chetan Pujamath. The two had come out in the early hours to take a short break from work. At that time, the accused, Prateek,

arrived at the spot in his car and asked Sanjay to buy a cigarette for him from a roadside vendor while he remained seated in the vehicle. Sanjay refused to fetch the

### NCP fumes over AI-generated fake video targeting party leadership

**Mumbai, Dec 26 :** The Nationalist Congress Party on Friday strongly condemned the circulation of a fabricated and AI-generated video, asserting that the video has been deliberately spread with the malicious intent of tarnishing the image of the party and its leadership. The party in a statement said that the video, widely circulated by political opponents across media and social platforms on the eve of the second phase of Nagar Parishad and Nagar Panchayat



elections slated for Saturday, represents a cheap and petty attempt to mislead the public through technological manipulation and misinformation. "The NCP immediately lodged a formal police com-

plaint upon becoming aware of the video. Subsequently, a forensic examination was sought. The Forensic Science Laboratory (FSL) report has now conclusively confirmed that the video in question is fake and AI-generated. The forensic findings are being placed in the public domain to ensure transparency and to establish the facts beyond any doubt," said the release. It said that the incident reflects the growing misuse of technology by those who lack political credibility and public support.
